Dear and Reverend Fathers,

Greetings from Bishop's House, Thuckalay!

Pope Francis, on the occasion of his Christmas message for the Roman Curia in 2014, spoke about some of the diseases that can cripple the effectiveness of ministry among pastors. He is of the opinion that in the life of a priest a constant examination of conscience would help him to be focused in his task. It had been the practice of the Desert Fathers who did it with the help of a prepared list, in order to prepare properly for the sacrament of Reconciliation. As Pope points out, a healing comes about through the awareness of one's sickness and their personal decision of patiently and perseveringly applying appropriate remedies. Pope Francis mentioned three sets of 5 diseases making fifteen probable diseases and temptations, which weaken the vital, personal, authentic and true relationship that a pastor should have with Christ. The ordering of the diseases is neither chronological nor sequential. In this letter, I am putting forward for your consideration seven of those diseases that Pope Francis mentioned.

The first disease is thinking that life of a priest is immortal, immune or indispensable: Those priests, who think in this way, turn to be lords and masters. They place themselves above others and not at their service. It is an effect of the pathology of power, from a superiority complex.

A priest may come from poor economic background or have poor intellectual capacities. In such a case the priest should have a balanced personality emerging from his spirituality that enables him to keep a humility and simplicity of life. He may be in whatever status of life in which he gets the calling of God. But some search for compensation in their status by thinking about themselves as priests in an exaggerated way and this happens to some of them. Sometimes it could be an outcome of a lot of money he has illegally accumulated in his priesthood and tries to show his power of money by lording over people.

It could also be a sheer act of immaturity of a priest who has not taken efforts to grow by having recourse to the Word of God and prayer to keep a correct profile of his life. He tends to forget that he is above all a servant to all parishioners. The example of the washing of the feet by Christ should touch and transform him.

Another disease is Martha Complex: There was a woman called Martha living with her brother Lazarus and her sister Mary. Jesus now and then used to stay in that family. The coming of Jesus to their family was to show that he was ready to listen to their burdens and problems of their lives and to impart the message of good news that would liberate them from several woes. He was there ready to hear in a sympathetic and patient way. Hence he gave them time by being present in their family. Mary understood this and sat down at his feet and poured out her problems especially those pertaining to her earlier life. She was expecting from Jesus the liberating words of God in order to

attain her peace of mind and heart as well as to be filled by the grace of God. Jesus appreciated her attitude and her values that she wanted to align herself along with the values of the Kingdom preached by Christ.

But her sister Martha had a different frame of mind. She wanted to give a big treat with several tasty dishes to Jesus. Hence she was too busy on that and even got tired in the course of the work. This made her feel that her sister Mary should have given a helping hand to her in this task and not sit idle with Jesus. This was a misjudgement of Martha on the whole situation. She pointed out to Christ that he should have asked her to help her work in the kitchen, meant to make Jesus happy.

Thus there were two sets of values at work: one set of values was to be busy for Jesus with worldly affairs like preparing a good meal and the second was to be busy with Jesus to reenergize oneself with the spiritual energy given by Christ. Likewise there are priests who busy themselves with several activities in the parish: some traditional works and some undertaken out of their goodwill for the welfare of the parishioners. In this process he is like Martha, busy and easily becomes a prey to fatigue that comes out like complaints by Martha. Jesus clarified that he came to them to have a meal with them you but what is more important is that Jesus wanted to spend his personal time with them talking, dialoguing and offering the life-giving message of God. In his presence at home they should seek the right choice like Mary.

Every priest should realize that he has in his midst in the chapel/church the presence of the Blessed Sacrament where Jesus is personally making himself available to the priest at whatever time and as long as he requires it. When a priest does not have this value system and practice it he has, as Pope says, Martha-complex, an excessive business mind and fatigue, emerging out of several social and other engagements, a priest undertakes either for himself or for his parishioners. The lacuna in such lives is that the priest does not create a balance and budgeting of time between being busy for people and finding the needed time with Christ in the Eucharist.

We must take a serious note of two instances in the Gospel: (Mk 6:31-32) "Then he said to them 'go off by yourselves to a remote place and have some rest'. For there were so many people coming and going that the apostles had no time to even eat. And they went away in the boat to a secluded area by themselves". Secondly (Mt 11:28-30): "Come to me all who work hard and who carry heavy burdens and I will refresh you. Take my yoke upon you and learn from me for I am gentle and humble of heart and you will find rest. For my yoke is good and my burden is light". The priest who says that his work is his prayer is a typical example of a priest with Martha-complex, personified.

The third disease is mental and spiritual petrifaction: Certain priests are filled with zeal after their ordination. But as days go because of their acquisition of wrong values and keeping a distance with Jesus internally they fall a victim to greediness of money that makes them demand money for any service they do forgetting, that a priest is ordained and is maintained for day to day life by the Church. This accumulation of money and increase in greediness manifest themselves by cheating in proper accountability and transparency in financial transactions with regard to the money of the Church and of people. With the accumulation of money there is a temptation to fall a prey to alcoholic drinks and in getting interested in unwanted relationships leading up to sexual misconduct with the other sex. It also leads to group-complex of priests to join with those priests of their vested interest and do mischief in their priestly life.

In short, such a deviation and disease lead to a hardness of heart that abandons the grace of God and the duty to show mercy to the poor and other Christians. These are priests who lose their sentiments of Jesus and people.

The fourth disease is excessive planning and functionalism: This is not a very common disease but found easily with those who always desire high posts in the diocese or who actually have responsible positions. Planning and its diligent execution are important and essential. But, to make it an end by itself, will multiply group activities under any responsibility and have too many meetings to plan. Planning becomes so excessive that it takes away much of the time of execution. When they reach a level of saturation in planning people may abandon it and they become thus disgruntled with people. Instead of blaming such a situation and the attitude of people they should look into themselves whether they have such a disease and get healed from it.

The fifth disease is poor coordination among several activities: It develops when the communion between members is lost. The body, then, loses its harmonious functionality and its temperance. It becomes an orchestra of cacophony because the members do not collaborate and do not work with a spirit of communion or as a team.

The sixth disease is spiritual Alzheimer: It consists of losing the memory of our personal salvation history, our past history with the Lord and our first love of his call to priesthood. Pope Francis summarizes it saying "We see it in those who have lost the memory of their encounter with the Lord."

This is one of the constant themes insisted by the Pope to priests. Priests are not selected because they are worthy of priesthood but they are selected by God and gradually by His Grace are formed them as His own priests if they cooperate with Jesus like the Apostles, except Judas. Each priest should realize his own history of sins and sometimes serious ones but forgiven by the mercy of God and entered into His embrace. He must also fully accept that if God's grace does not continually enrich him by his daily encounter with Jesus in the Eucharist and in his personal prayer his life would be in shambles. When he loses his memory of his own history of salvation he fails to become an instrument of God to bring a personal transformation in the lives of his parishioners.

The ministry and the life of a priest remain faithful to God and to his ministry among people only if he remembers that as a priest how dependent he was and is in his relationship with Jesus and its deepening and enrichment through his prayer life. Every priest should look into himself to see whether the disease of spiritual Alzheimer is gradually setting into his life or has already set in. The physical Alzheimer disease does not have today much remedies but the disease of spiritual Alzheimer has very effective healing means at our disposal. Unless we know the way out we will not be able to take it.

The seventh disease is rivalry and vain glory that arises out of titles of honour: There are different titles of honour in every diocese: The Vicar General, the Procurator, the Chancellor, the Vicar Forane, Director of a Diocesan Centre, Coordinator of Commissions, etc. All these titles of honour are meant for services to priests and to several parishes. When a priest takes away the essential element of service and commitment he keeps holding on only to titles, given to him. It is like honey, taken away from the beehive, and it becomes an empty honeycomb. The honey gatherers will not go after it except to make some commercial use like making wax candle.

When title of honour loses its quality of service and commitment, they become mere titles. In such cases there could be a temptation that the title of honour is loved and esteemed greatly by the person who is given them. The title is loved for itself, as a sign of honour and the person tends to love himself and desires further honours to be given by others because of his title or position of power. Instead of commanding honour they may start demanding it and place oneself in a self-made hierarchy of honours. It tempts one to change his language of love and respect into one of asserting one's power position and domineering tendencies. This sickness directly clashes with the values of

Christ who washed the feet of his disciples and admonished them against such temptations and disease. Jn 13:12- 15 "Do you understand what I have done to you? You call me Master and Lord, and you are right, for so I am. If I, then, Your Lord and Master, have washed your feet, you also must wash one another's feet. I have given you an example that as I have done, you also may do. Truly I say to you, the servant is not greater than his master, nor is the messenger greater than he who sent him. Understand this, and blessed are you if you put it into practice."

The above-mentioned diseases of Pope Francis are the fruit of his reflection arising from his long years of ministry as priest, as Bishop and as Cardinal. Like a good steward, he has drawn, from the stock of his experiences these reflections to enrich the lives of priests. It shows the deep authentic faith life of Pope as well as his love and concern for his priests. Let us give a thought to them and make a serious reflection on our own life as priests.

NEWS AND EVENTS

Catechism Department: The Eparchial level Catechism Annual Day celebration was held on 9 July 2017 at Kalluvilai. Rev. Fr. Thomas Sathianesan, the Eparchial Chancellor, was the chief guest and Rev. Fr. Dency Mundunadackal and Rev. Fr. Justin Cheruvelil were invited as the guests of honour for the celebration. The catechism children who had won first prizes in the Eparchial level competitions performed a number of items showcasing the talents and gifts that God has showered upon them. The people who served for 25 years as catechism teachers were gratefully remembered and honoured during the programme. I express my sincere gratitude to Rev. Fr Alex Puthettu, Director of catechism, Rev. Fr Ritto Thoompunkal, Assistant Director, promoters, head masters, teachers and the helpers who serve the Eparchy by imparting faith to our young boys and girls. Let us continue to pray for the growth of our catechetical apostolate.

Feast of St Alphonsa at Nagercoil: St. Alphonsa is the first Saint from the Syro-Malabar Church. We are blessed to have a Shrine in her honour at Nagercoil. It is the pilgrim Centre in our Eparchy. The feast day celebrations were well organized for 10 days and thousands of people participated in the celebrations. People in large numbers including many of Fathers participated in the *Nadaipayanam*, which was held on 29 July. They walked many miles praying the Rosary to reach the Shrine. 30 July was the Eparchial Pilgrimage Day. Thousands of faithful from our parishes thronged the St Alphonsa Shrine and took part in the Holy Qurbana, over which I presided. It was gratifying to see the people taking part in the procession at the end of the mass carrying the statues and relics of the saints. I was happy that many Fathers came with their faithful and took part in the programme. I know, many of you visited the shrine on other days as well. I thank you, dear Fathers, for making this feast truly memorable and spiritual. I also sincerely thank Rev. Fr. Thomas Powathuparampil, Rev. Fr. Ajin Jose and the parishioners for their hard work in organizing the celebrations in a best way possible.

Blessing of the Additional Floor at Sangamam: The newly constructed second floor and the renovated chapel at Sangamam were blessed on 18 July 2017. Now we are able to accommodate nearly sixty people in Sangamam. I sincerely congratulate and thank Rev. Fr. Johnsilal Arackaparambil and Rev. Fr. Dency Mundunadackal who worked hard for the completion of the construction. I thank you, dear Fathers, for your prayers and participation during the blessing. Let us remember our benefactors who helped us to complete this work.

TNBC: The summer session of the Tamil Nadu Bishops Council (TNBC) was held from 9-11 July at Velankanni. On 9 July, there was TNPPC meeting. Some representative of the Pastoral council along with Rev. Fr. Jose Muttathupadam, Vicar General, attended this meeting. The private meeting of

Tamil Nadu Bishops began on 10 July. All the Bishops except two were present for the meeting. Various issues related to the Tamil Nadu Church were discussed. We were asked to give more support to Matha TV and to the issues arising out of the Enayam Port. The Oriental Bishops ended the meeting on 11 July.

Shenkottai Mission: I visited the Shenkottai mission on 22 July and blessed the newly built Computer lab of Pulari School. Rev. Fr John Paul, Principal of the school, prepared a beautiful computer lab and painted five classrooms of the lower primary. At 6.00pm we started the recollection talk and it was followed by benediction in the Vanchinagar Church. The regular meeting of Fathers and Sisters of Shenkottai Mission was held at CMC house, Vanchinagar.

Rev. Fr. John Paul, Coordinator of the Mission, thanked everyone for their active presence in the Mission. He also announced some new initiatives. From the month of August, the Shenkottai Mission is going to begin Convention on second Saturday of every month for the faithful at Vanchinagar. He requested the prayerful support of every one for the success of this new venture. He invited all the Fathers and Sisters to join the faithful in giving them spiritual energy. With the support of Rev. Fr. Seby Manimalakandathil, the Shenkottai Mission is going to form a choir group. All those who present in the meeting welcomed these new initiatives. We are grateful to the Mission Coordinator, to all the Fathers and to all the Religious of Shenkottai Mission.

Muzhucode Parish Turns Gold: The inauguration of golden jubilee celebration of St. Thomas Church, Muzhukode was held on 2 July 2017. It coincided the parish day celebration. Inter-Eparchial Meeting: The Inter-Eparchial Meeting was held on 13 July at Changanassery. Nearly fifty members along with Bishops from the four Dioceses were present.
